# **Privacy Policy**

This is the Privacy Policy of the Coalition for Global Health Innovation, hereinafter referred to as "CGHI". CGHI is established under Swedish law, with registered office at Skatteverket.

This Privacy Policy sets out CGHI's general policies on data privacy and protection, and it seeks to inform interested parties about the data we collect, the purpose for collecting it, the way we use it and the rights you have regarding the processing of such data.

The following version was last modified on April 13<sup>th</sup> 2021, and it may be amended in case of future changes on the website, major amendments will also be notified through the website.

CGHI is strongly committed to protecting your privacy and complying with your choices.

- Your information will not be rented or sold to any third party unless disclosed in this Privacy Policy.
- You have the possibility to control the information that you shared with us through an opt-out system.

#### I. CGHI as data controller.

CGHI is the controller for the processing of your personal data and hereby committed to protecting your privacy.

## II. CGHI, Google and Squarespace Analytics are data processors.

Your personal data will be processed by CGHI, Google and Squarespace Analytics as specified below, but it will not be rented or sold to any other third party unless included in this Privacy Policy.

#### III. Type of personal data processed and collected by CGHI.

CGHI is processing personal data in the context of your use of the website, online applications and/or attendance of one or more of the CGHI events or activities.

CGHI collects and uses the following personal data about you:

Contact information: first name, last name and email address.

<u>Identity verification information</u>: date of birth.

Others: nationality and personal projects/ideas.

CGHI also processes non-identifiable information when you visit its website in relation to our contractual agreement with Google Analytics and Squarespace Analytics, such as your IP address, browser, the time and duration of your visit, URL, time zone setting etc. It does so through the use of cookies as explained in section IV.

CGHI discloses personal information to third parties only when it is necessary for the purposes specified and only to the categories of the recipients identified. CGHI does not divulge any personal data for direct marketing purposes and undertakes to take appropriate security measures to safeguard these data from misuse by third parties.

## IV. Cookies.

CGHI employs cookies to improve your website experience by checking the overall page performance and user's content preferences.

A cookie is a small data file that is placed on your computer or other device to allow a webpage to recognise you as a user when you return using the same device and web browser, either for the duration of your visit (using a 'session cookie') or for repeated visits (a 'persistent cookie').

You are able to restrict or block cookies by installing Google Analytics' opt-out browser addon or by opting out through the cookies consent banner on our website, even though you might miss certain features available thereby.

## V. Purpose and objective of the data processing.

CGHI processes personal data for the following purposes:

- To provide you with information about our activities and/or events.
- To invite you to our community platforms.
- If applicable, to let other community members know about any shared interest you may have with them.
- To make the website easy to use and for its technical and functional management.

We collect your email address and name in order to keep in touch with you and enable you to engage in the network.

We collect your nationality mainly for internal purposes, as we aim to be diverse, international organisation and knowing where our community members are from will help us keep track of that, but also target our content and efforts accordingly.

We collect information about you and any possible idea/project/action you would like to initiate within CGHI (optional) in order to better connect you with people with similar interests within our network. In addition, we may use this information (anonymised) in development purposes for the organisation.

We collect information about you also to make contact in the context of a selection and recruitment process. When you apply for a job through the website, we process your personal data in order to contact you and to follow up your application.

CGHI processes this information based on:

- your request to take steps prior to entering into a contract or
- the necessity to execute a contract with you or
- your consent.

#### VI. Protection of personal data and duration of storage of personal data.

CGHI takes reasonable security measures to protect your personal data from destruction, loss, modification or any other unauthorised processing.

CGHI does not store your personal data for longer than necessary for the purposes for which it is stored.

## VII. Data Subject Rights.

You have the following rights, which you can exercise free of charge:

<u>Access</u> (Art. 15 GDPR): the right to be provided with a copy of your personal information (the right of access).

<u>Rectification</u> (Art. 16 GDPR): the right to require us to correct any mistakes in your personal information.

<u>To be forgotten</u> (Art. 17 GDPR): the right to require us to delete your personal information in certain situations.

Restriction of processing (Art. 18 GDPR): the right to require us to restrict processing of your personal information in certain circumstances, e.g., if you contest the accuracy of the data. Data portability (Art. 20 GDPR): the right to receive the personal information you provided to us, in a structured, commonly used and machine-readable format and/or transmit that data to a third party in certain situations.

<u>To object</u> (Art. 21 GDPR): the right to object to the processing of your data at any time.

For further information on each of those rights, including the circumstances in which they apply, please contact us.

#### VIII. Consent

When you provide your personal information, you consent that it can be used for above purposes and that CGHI is an authorized holder of such information.

## IX. Opt-out

You will always have the opportunity to opt out from receiving newsletters and other communications from us. You can opt-out by a provided opt-out option or by contacting us via email.

## X. Storage and access

The information is stored on our account's G Suite-account in a spreadsheet. Any member of the CGHI Steering Group may have access to this information.

## XII. Changes to this policy

If we make changes to our Privacy Policy, we will upload the updated policy to the website. If we at any point decide to use your information in a manner different from that stated at the time it was collected, we will notify you by email.

## XII. Enforcement of policy

If for some reason you believe CGHI has not adhered to these principles, please notify us and we will do our best to promptly make corrections.
